SUMMARY ANNUAL REPORT

FOR LOCALS 302 AND 612 OF THE INTERNATIONAL UNION OF OPERATING ENGINEERS CONSTRUCTION INDUSTRY HEALTH AND SECURITY PLAN

This is a summary of the annual report of the Locals 302 and 612 of the International Union of Operating Engineers Construction Industry Health and Security Plan, E.I.N. 91-6028570, Plan No. 501, for the year ended March 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Delta Dental of Washington, Willamette Dental of Washington, Inc., Kaiser Foundation Health Plan of Washington, United Healthcare Insurance Company, United of Omaha Life Insurance Company and HCC Life Insurance Company to provide certain benefits incurred under the terms of the plan. The total premiums paid for the plan year ended March 31, 2024 was \$3,797,904.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ended March 31, 2024, the premiums paid under such "experience-rated" contracts were \$682,659 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$500,534.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$181,958,361 as of March 31, 2024, compared to \$187,487,436 as of April 1, 2023. During the plan year, the plan experienced a decrease in its net assets of \$5,529,075. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$191,240,903 including employer contributions of \$151,635,909, participant contributions of \$17,878,911 and gain from investments of \$21,726,083. Plan expenses were \$196,769,978. These expenses included \$3,088,335 in administrative expenses and \$193,681,643 in benefits paid to or for participants and beneficiaries.
